**IEP Information:**

- ✓ **Parents may request an evaluation at any time (must be in writing) – Chapter 14: 14.123C. Evaluations MUST be completed, with the report to the parents, no later than 60 calendars days after the agency receives written consent, not counting the calendar days from the day after the last day of spring term to the day before the first day of the subsequent fall term – Chapter 14: 14.123(b).**
